A special resolution to make changes to LELAN's constitution, in accordance with the Associations Incorporation Act 1985. It is intended that the following motion be proposed as a special resolution:



That the current Constitution of SA Lived Experience Leadership and Advocacy Network Inc (LELAN) be repealed and the proposed new Constitution attached to the notice of the meeting of the members of LELAN, be adopted as the Constitution of LELAN.

The new Constitution showing all proposed deletions in yellow highlight and additions in teal highlight can be accessed here. Changes have been made to update board appointment and voting, definitions of lived experience board and membership categories, stipulations around vacancies mid-term, removal of disqualification criteria, updating communications to be email in line with current practice and change to the definition of quorum.
